POTENTIAL COSTS TO THE RECEIVING ORGANIZATION INCLUDE

- 1.) Limited Demilitarization: Equipment has undergone partial demilitarization, but remaining work will need to be completed by receiving organization. Work to be performed will include, but may not be limited, the welding of all doors and hatches to prevent access to interior.
- 2.) Equipment Restoration: Equipment will require restoration work to bring it to display quality. All restoration, maintenance, and repair of static display equipment is the responsibility of the receiving organization as our program runs at no cost to the government and we do not have access to any replacement parts, accourtements or supplies. We recommend that you seek out commercial sources to complete the restoration work. Some organizations choose to fundraise or reach out to their community for support and have been able to obtain donated parts and services. Attached is a Maintenance and Preservation Information Sheet that provides paint suggestions and recommendations for going forward with restoration work.
- 3.) Display Site Construction: Receiving organization will be required to construct a concrete or gravel pad for the equipment to be displayed on. DO NOT PROCEED WITH CONSTRUCTING THE DISPLAY PAD WITHOUT PRIOR AUTHORIZATION FROM OUR OFFICE.
- 4.) Transportation: The cost to move the military equipment from its current location to the display site is the responsibility of your organization. If your organization is offered the equipment, you will need to provide a letter from the organization that will transport the piece from its present location to the new display site. The company should be licensed and certified by the Department of Transportation. The letter must be on the company's letterhead and include a point of contact, address, telephone/fax number/email address and the DOT

MAINTENANCE AND PRESERVATION INFORMATION SHEET

Conditionally donated US Army property is issued in an "AS-IS" condition. It is the responsibility of the civilian organization to touch up or to completely repaint the item in order to make it an attractive display.

Most government vehicles are painted with chemical agent resistant coating (CARC). If sandblasting is required on an asset with this coating, use extreme caution. It is strongly recommended the painter(s) wear a breathing apparatus to protect against potential airborne particles of the CARC paint. Please note lacquer will not adhere to CARC coating; therefore, do not use lacquer on the asset.

Organizations are not authorized to paint the Army asset for advertising purposes. Each organization is required to display and maintain the item in such a way that it honors and upholds the image of the United States, our military forces, and the veterans. Post emblems, camouflage patterns, stars, lettering, numbers, and other appropriate insignia are permissible, as long as the image of the United States Government is not degraded. Please contact the Army Donations Program Office for clarification if you are unsure of what is permissible.
