

List of Available Subcontractors

Instructions for Submitting a Vendor Profile to the Available Subcontractor List

The Office of Small Business Programs at US Army Tank-automotive and Armaments Command (TACOM) maintains a list of prospective subcontractors of all socioeconomic types for ready referral by the Command's prime contractor community and contracting personnel. **However, be aware that the information you submit will be made available to anyone who requests it.**

This list, which will be updated with new profiles continuously, provides vendors with an easy and centralized means of announcing their availability as subcontractors under current and forthcoming TACOM prime contracts -- but be advised that appearance on the list does NOT constitute endorsement by TACOM nor does it guarantee a subcontract.

NOTE: Your company profile will be on the list for twelve (12) months from the date you submit. After that, it will be removed and you will have to re-submit your information to get on the list again.

If you wish to add your business concern's profile to the TACOM Available Subcontractor List, follow these simple steps:

- 1) Read the explanations below carefully before completing each entry on the form in step 2.

Entry	Explanation
Business Name	Enter the name of your business concern.
Location	Enter the city and state (or city and country) of your business concern.
CAGE Code	Enter your business concern's five-digit CAGE (Contractor and Government Entity) code. If you don't have a CAGE code visit www.sam.gov to register and obtain one.
Small Business?	Enter Y or N depending on whether your firm qualifies as a U.S. Small Business under one or more NAICS (North American Industry Classification System) categories. Refer to https://www.sba.gov/federal-contracting/contracting-guide/size-standards to find out how Small Business status is currently defined for each NAICS category.
Socioeconomic Status	Enter as many of the abbreviations below that apply to your business concern. 8(a) : 8(a) Program Participant (SBA certification required) SDB : Small Disadvantaged Business WOSB : Woman-Owned Small Business EDWOSB : Economically Disadvantaged Women-Owned Small Business HZSB : HUBZone Small Business (SBA certification required) VOSB : Veteran-Owned Small Business SDVOSB : Service Disabled Veteran-Owned Small Business A1 : AbilityOne agency for the blind & otherwise disabled NP : Not for Profit HBCU : Historically Black College or University MI : Minority Institution
Website	Enter your business concern's homepage.
Point of Contact	Enter the name of the individual who will respond to inquiries on behalf of your business concern, followed by that person's title, phone number and e-mail address.
Main Line of Business	Enter a short description of no more than 5 words that identifies your concern's line of business in broad terms (for instance "Precision Machining," "Electronics," "Engineering Services," or "Consulting Services").
Capability Narrative	Enter a narrative of up to 100 words that defines your concern's capabilities and/or interest areas, making note of whether it has Defense contracting or subcontracting experience; whether it possesses any special qualifications or certifications; and whether it is registered on a GSA Schedule. Do not exceed 100 words or the narrative will be cut down to the first 100 words! DO NOT furnish attachments of any kind.
Submission Date	Enter the date of submission of your business concern's profile.
